

The Authority hereby grants Generation Licence to Lt. Col. (R) Abdul Latif Awan, for 10.08 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 362558, located at Plot # 71/2, Street # 8, Phase V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
