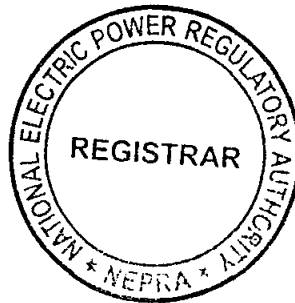




The Authority hereby grants Generation Licence to Mr. Bilal Ahmad for 24.00 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 895450, located at 152/II, P Street, Off Khyaban Muhafiz, Phase VII, DHA Phase, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 12<sup>th</sup> day of Oct. 2027.
