

The Authority hereby grants Generation Licence to Mr. Asadullah Khuhro, for 21.78 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 609242, located at Plot # 15, Street # 15, Khayaban-E-Touheed, Phase V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
