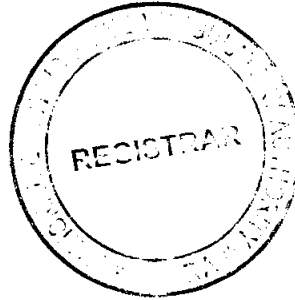



The Authority hereby grants Generation Licence to Mr. Arif Hashwani, for 25.11 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 240096, located at Plot # F/7, Street # 7, KDA Scheme 5, Clifton, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
