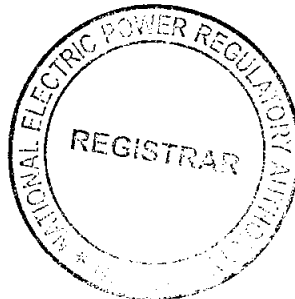



The Authority hereby grants Generation Licence to Muhammad Ali Choudhary, for 9.75 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 262044, located at Plot No. 83/2, Street-29, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
