

The Authority hereby grants Generation Licence to Syed Shahid Hussain Naqvi, for 6.12 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 136586, located at Plot No. 175/1, Khayaban-e-Amir Khusro, Phase VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
