


The Authority hereby grants Generation Licence to Mr. Qasim Nadeem, for 11.88 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 729353, located at Plot # C24, Darakhshan Scheme, Phase VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
