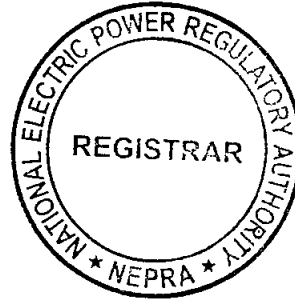



The Authority hereby grants Generation Licence to Mrs. Amana Aziz, for 16.08 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 441947, located at P/No. 87 B, Gulshan e Faisal Co Op Housing Society, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
