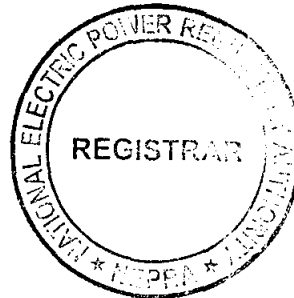




The Authority hereby grants Generation Licence to Mr. Muhammad Saleem, for 10.48 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 103172, located at C-179, Block 14, G-Johar, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
