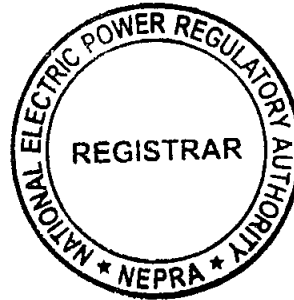

The Authority hereby grants Generation Licence to Mr. Abbas Lakdawala, for 20.37 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 194509, located at Plot # 173/II, 29th Street, Phase-VIII-A, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
