

The Authority hereby grants Generation Licence to Mr. Anjum Anis Ansari, for 20.01 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 177972, located at Plot # 180/III, Street # 15, Phase VIII-B, Defence, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
