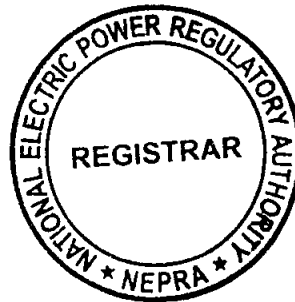



3. The technical parameters of Net Metering arrangements are shown hereunder:-

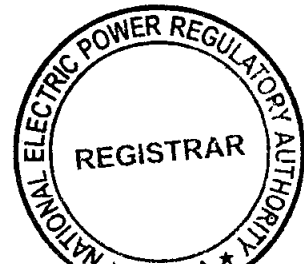
