


The Authority hereby grants Generation Licence to Mr. Hassan Tariq, for 13.92 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 035208, located at Plot # I.H, 222 Falcon Complex, PAF Housing, AFOHS PECHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
