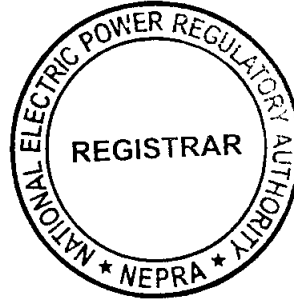




The Authority hereby grants Generation Licence to Mr. Azher Mustafa Karimjee, for 10.10 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 165328, located at Plot # 95-A, Zulfiqar Avenue, Phase-VII-B, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
