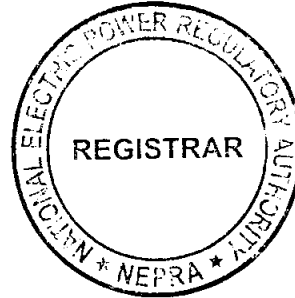




The Authority hereby grants Generation Licence to Mrs. Maria Zahoor, for 8.60 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 168995, located at Plot # 73/P/6, PECHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
