


The Authority hereby grants Generation Licence to Mrs. Uzma Muzzammil, for 10.0 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 829664, located at Plot # 241/1-C/2, PECHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 25th day of Feb. 2028.

2. The Licensee shall abide by the provisions under the A&RE Regulations during the currency of the Generation Licence.
