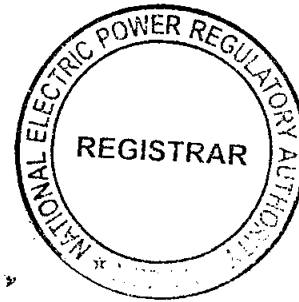



The Authority hereby grants Generation Licence to Mrs. Shirin Bai, for 18.13 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 103591, located at Plot # 13/F/6, PECHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
