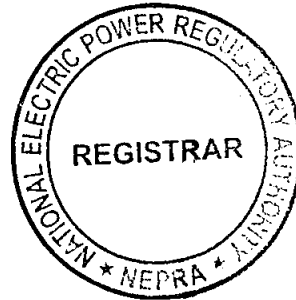



The Authority hereby grants Generation Licence to Mr. Saeed Ahmed Siddiqui, for 10.80 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 909073, located at Plot # 110/1, Khyaban-e-Shujaat, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
