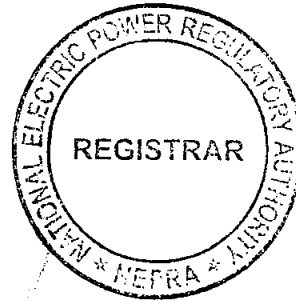



The Authority hereby grants Generation Licence to Mr. Yousuf Suleman Omerson, for 11.61 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 676542, located at Plot A/65/2 BL 728, Adamjee Nagar, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
