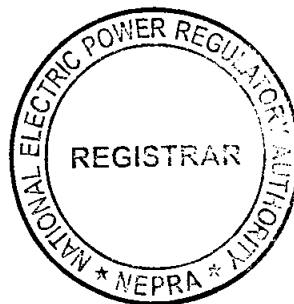



The Authority hereby grants Generation Licence to Mr. Muhammad Anis Shamsi, for 20.64 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 347628, located at Plot # 8-A/2, North Circular Avenue, Phase-1, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
