

The Authority hereby grants Generation Licence to Sheikh Kamran Illahi, for 19.575 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 388715, located at Plot # 105/1, Street 8, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
