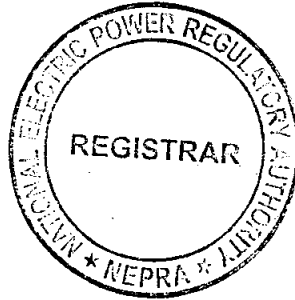



The Authority hereby grants Generation Licence to Mr. Siddique Gul Agha, for 10.165 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 378434, located at Plot # 2A/1, North Circular Avenue, Phase-1, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 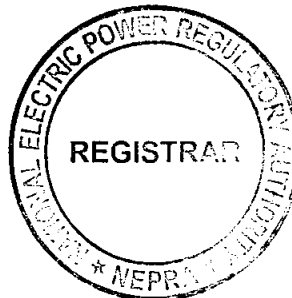
