


The Authority hereby grants Generation Licence to Mr. Muhammad Nasir Uddin Khan, for 5.40 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 409414, located at Plot # D-66, Navy Housing Scheme, Phase V, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
