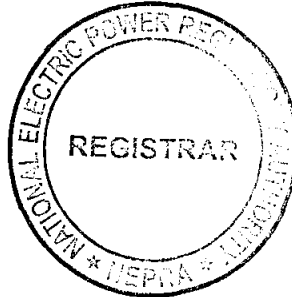




The Authority hereby grants Generation Licence to Mr. Moinuddin, for 10.29 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 610312, located at Plot # B-60, Block-3, Gulshan-e-Iqbal, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
