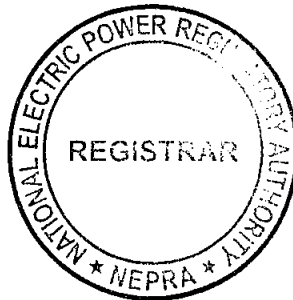



The Authority hereby grants Generation Licence to Mr. Muhammad Ali Sheikh, for 5.6 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 061013, located at Plot # R-09, Block No.03, Gulistan-e-Johar, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
