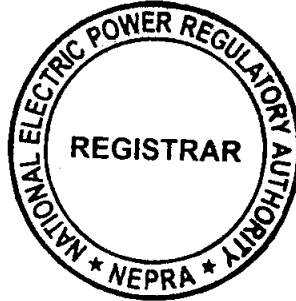



The Authority hereby grants Generation Licence to Shafiq Bilwani, for 13.91 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 192256, located at Plot # 5-B, South, Street 3, Phase II, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 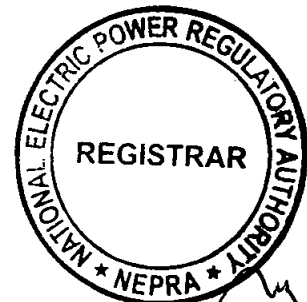
