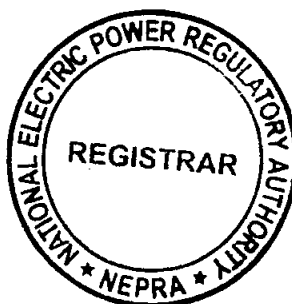


The Authority hereby grants Generation Licence to Mr. Muhammad Hussain, for 18.90 KW photovoltaic solar based distributed generation facility, having consumer reference number LB302986, located at Plot No. E-16, Block-F, Gulshan-e-Jamal, PECHS, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
