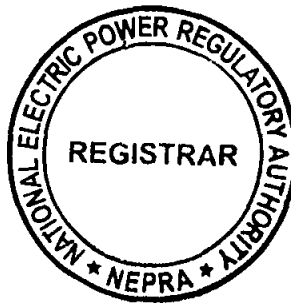




The Authority hereby grants Generation Licence to Mr. Javed Latif, for 10.165 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 012294, located at Plot No.F-40/1, Block-F, North Nazimabad. Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
