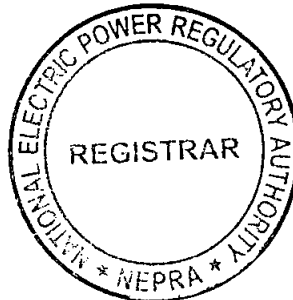

The Authority hereby grants Generation Licence to Mr. Muhammad Asif Polani, for 16.00 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 209145, located at Plot # 106/II, 3rd Street, Phase VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 2. The Licensee shall abide by the provisions under the A&RE Regulations during the currency of the Generation Licence.


