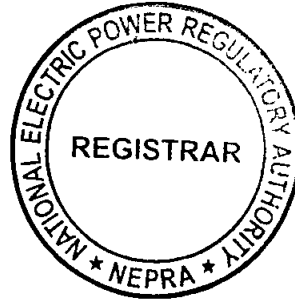




2. The Licensee shall abide by ^{July,} the provisions under the A&RE Regulations during the currency of the Generation Licence.
