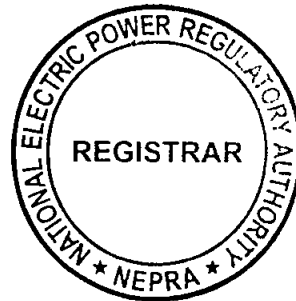



2. ^{July,} The Licensee shall abide by the provisions under the A&RE Regulations during the currency of the Generation Licence.


