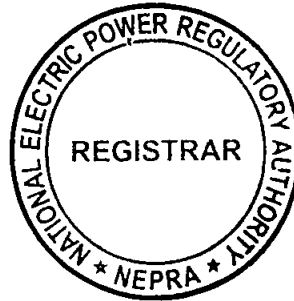




The Authority hereby grants Generation Licence to Mr. Ali Ur Rehman, for 10.8 KW photovoltaic solar based distributed generation facility, having consumer reference number AL451019, located at Plot No. E-21-1 Block 4 Gulshan-e-Iqbal Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
