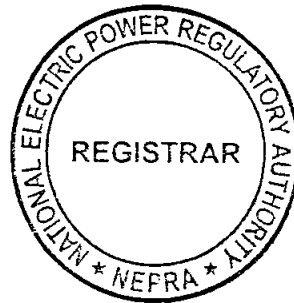



The Authority hereby grants Generation Licence to Master Agro, for 196.0 KW photovoltaic solar based distributed generation facility, having consumer reference number BBB-BH001209, located at Plot No. C-12 Bin Qasim Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 2. The Licensee shall abide by the provisions under the A&RE Regulation during the currency of the Generation Licence.

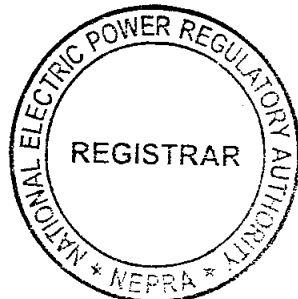
