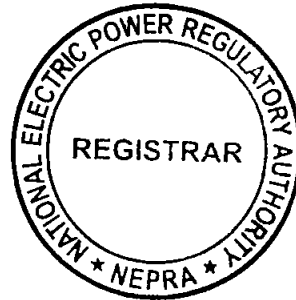




The Authority hereby grants Generation Licence to Haji Abdul Khaliq, for 15.12 KW photovoltaic solar based distributed generation facility, having consumer reference number AL914712, located at Plot No. 33 Khayaban-E-Jabal Phase-V DHA Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
