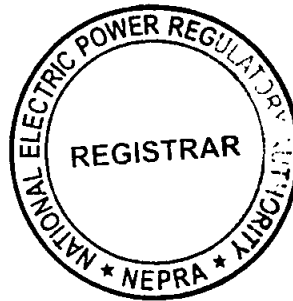



The Authority hereby grants Generation Licence to UDL Distribution Pvt Ltd, for 39.96 KW photovoltaic solar based distributed generation facility, having consumer reference number BL003599, located at Plot 44 Block/E Sector 31/D P&T CHS Korangi Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
