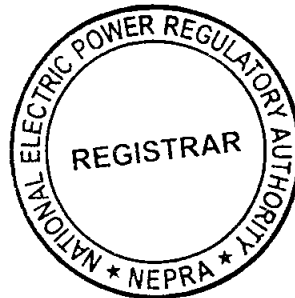



The Authority hereby grants Generation Licence to Mr. Shahid Tawawalla, for 26.75 KW photovoltaic solar based distributed generation facility, having consumer reference number BL 004634, located at 145, 30<sup>th</sup> Street, VIII-A, Phase VIII, Defence, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. This Licence is valid up to 22<sup>nd</sup> day of Aug 2028.

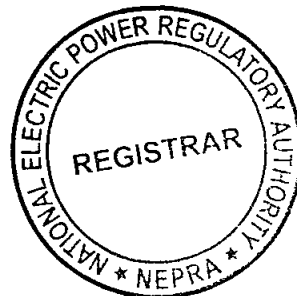
