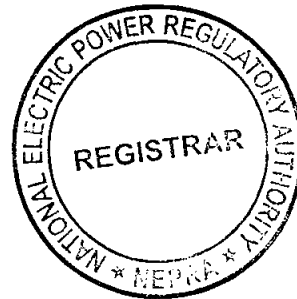



The Authority hereby grants Generation Licence to Mr. Naeabzada Rehmat, for 25.14 KW photovoltaic solar based distributed generation facility, having consumer reference number LA543662, located at Plot No. 95/2, Street-20, Khayaban-e-Rahat, Phase-VI, DHA Karachi, under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
