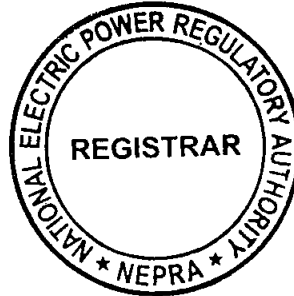



The Authority hereby grants Generation Licence to Mst. Kulsoom Bilwani, for 11.77 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 286070, located at Plot # 25/2, Gizri Street 3, Phase IV, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 3. The technical parameters of Net Metering arrangements are shown hereunder: -

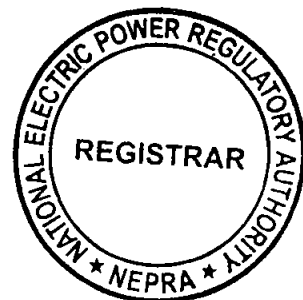
