

The Authority hereby grants Generation Licence to Mr. Rehan Bhaila, for 17.655 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 265848, located at Plot # C-210, 1, KDA Scheme # 1, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
