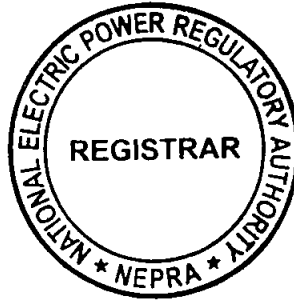



**GENERATION LICENCE**

The Authority hereby grants Generation Licence to Dr. Arshlioz Jamila Rahman, for 14.70 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 360255, located at Plot # D-23, KDA Scheme # 1, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
