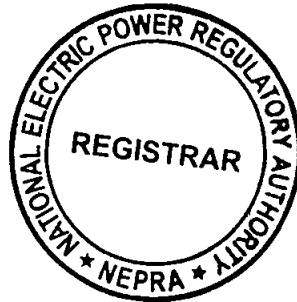



**GENERATION LICENCE**

The Authority hereby grants Generation Licence to Mst. Ambreen Khalid, for 8.025 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 006332, located at Plot # 3A/I, West, Street # 2, Phase I, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 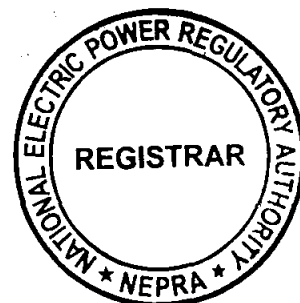
