

The Authority hereby grants Generation Licence to Mst. Yasmeen, for 16.00 KW photovoltaic solar based distributed generation facility, having consumer reference number AM 229733, located at C-27, Block 8, Scheme 24, Works Co-Operative Housing Society, Gulshan E Iqbal, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
