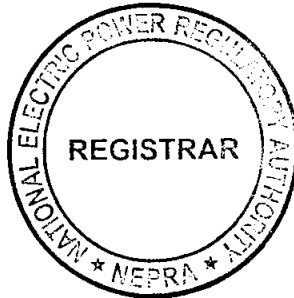



The Authority hereby grants Generation Licence to Mr. Basharat Rasool, for 10.16 KW photovoltaic solar based distributed generation facility, having consumer reference number LB 298615, located at Plot No.R-10, Works CHS, Block-IV, Scheme-36, Gulistan Johar, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 3. The technical parameters of Net Metering arrangements are shown hereunder: -

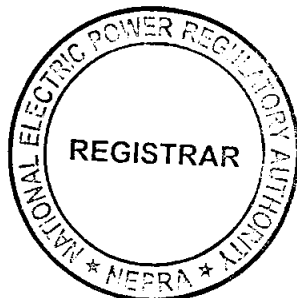
