

The Authority hereby grants Generation Licence to Mr. Fahim Zakriya Bilwani, for 12.30 KW photovoltaic solar based distributed generation facility, having consumer reference number LA 112966, located at Plot No.25/2, Gizri, Street No.3, Phase-IV, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
