

The Authority hereby grants Generation Licence to Syed Hassan Eijaz, for 6.48 KW photovoltaic solar based distributed generation facility, having consumer reference number LB297037, located at Plot No. A-112, Block-13-D-I, Gulshan-e-Iqbal Karachi, under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 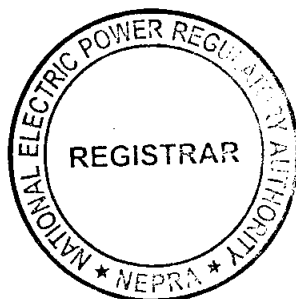
