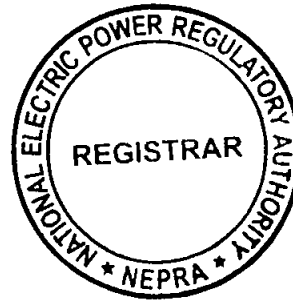



2. The Licensee shall abide by the provisions under the A&RE Regulation during the currency of the Generation Licence.

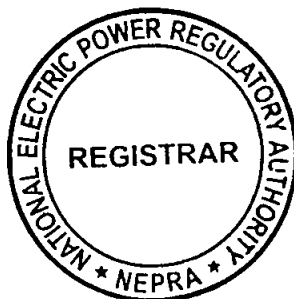
