

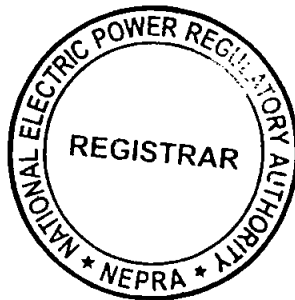

The Authority hereby grants Generation Licence to Mrs. Misbah Shafqat, for 20.52 KW photovoltaic solar based distributed generation facility, having consumer reference number LA718083, located at P No. 99, Street 3, Phase-VI, DHA, Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
