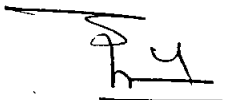

The Authority hereby grants Generation Licence to Mr. Mohammad Irfan, for 5.400 KW photovoltaic solar based distributed generation facility, having consumer reference number LB142778, located at B-32, Block-13 Gulistan-E-Johar Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years.
