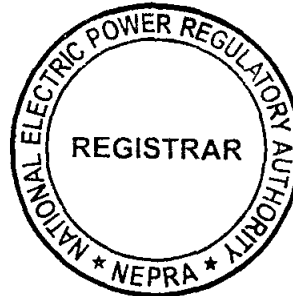

The Authority hereby grants Generation Licence to Vice Admiral Azhar Shamim Anwar, for 10.165 KW photovoltaic solar based distributed generation facility, having consumer reference number LB195207, located at Plot # B-77, Navy Housing Scheme, Phase-V, DHA Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 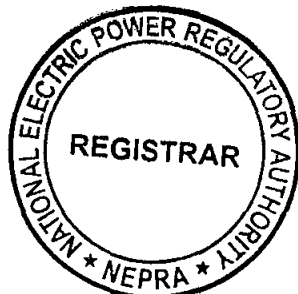
