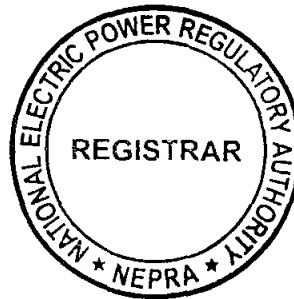



The Authority hereby grants Generation Licence to Mrs. Rahila Iftikhar, for 11.880 KW photovoltaic solar based distributed generation facility, having consumer reference number AL 773821, located at Plot No.66/2, Street 12, Khayaban-E-Badban Phase-V, DHA Karachi under the National Electric Power Regulatory Authority (Alternative & Renewable Energy) Distributed Generation and Net Metering Regulations, 2015 (the "A&RE Regulations") for a period of seven (07) years. 2. The Licensee shall abide by the provisions under the A&RE Regulations during the currency of the Generation Licence.

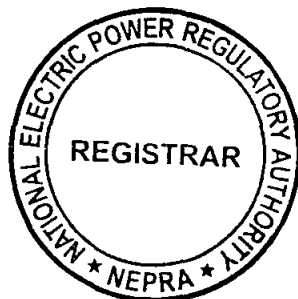
